## Board Meeting December 9, 2020



During Wednesday night's Board of Director's meeting, all board members were in attendance, along with Diane Barta, Onsite Community Manager, Richard Lester, Compliance Coordinator, And

Vanessa Burch, Director of On Site Operations . In addition, 18 homeowners attended the virtual board meeting that was held over Zoom.

Diane Barta, On-site Community Manager, read aloud the Executive Disclosure, which recaps all actions taken during the Executive Session portion of the meeting.

During the Manager's report, Diane provided a brief update on the Financials for October stating that the total Cash and Investments were: \$ 4,018,777, which the total makes up the Operating Account of \$2,849,694 and the Reserve Account of \$1,168,783.

Diane updated the Board about leak detections for the pool at Leisure Lane, additional holiday decorations that were added to the pavilions on Sunflower and at Walker, RFPs that are being prepared for estimates to add electricity at additional monuments, and the preparation of annual meeting materials. Richard updated the Board on the number of violations and ARC requests for November.

During the meeting, the Board approved the budget for 2021 with additional funds allocated to the holiday lighting. The Board also voted to renew the community's insurance policy with a minor increase in coverage.

The Board finished with homeowner questions about holiday decorations and adding electricity to areas of the community.

The meeting was adjourned at 7:55 PM.



## Mountain Lion Spotted in Collin County




TPWD recently confirmed trail-camera photos of a mountain lion near Princeton, in Collin County. The photos were time-stamped December 7, 2020. This is about 20 miles north of the mountain lion photographed in Rowlett on November 22, and it is possible they are of the same individual.

Mountain lions can be found in much of Texas and rarely create conflict with people. When living in areas with possible mountain lion activity, TPWD recommends residents do not allow children and small pets to play outside unsupervised. Attacks on people are extremely rare with fewer than 30 confirmed fatal mountain lion attacks on people in North America in the last 100 years.
