

During the Manager's report, Diane provided a brief update on the Financials for June stating that the total Cash and Investments were: \$4,055,508, which the total makes up the Operating Account of \$2,579,034 and the Reserve Account of \$1,476,173. Reviewed projects in process within the community.

Diane updated the Board about pool schedules, holiday decorations and lighting, the CAI study which Two Sunset Pointe will take part in, algae and weed growth in the lakes, repairs needed to the sidewalks around common areas, and landscape maintenance. Richard updated the Board on the number of violations and ARC requests for August.

The Board voted to approve the date of September 27, 2020 as the final day for the pools to be open for the season.

The meeting was adjourned at 7:33 PM.

beauty. All winners receive gift cards as a thank you from the HOA for keeping Sunset Pointe looking great!


